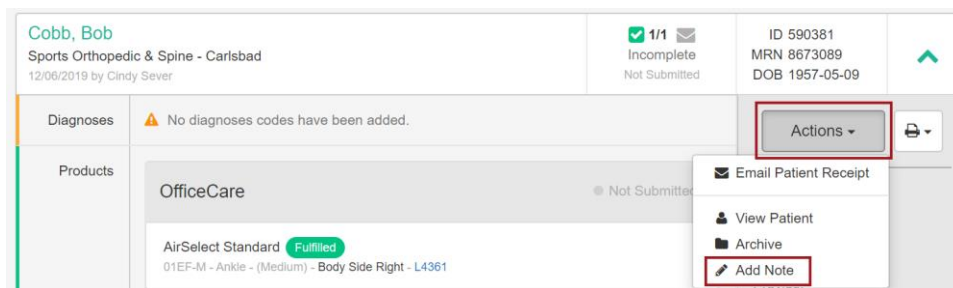

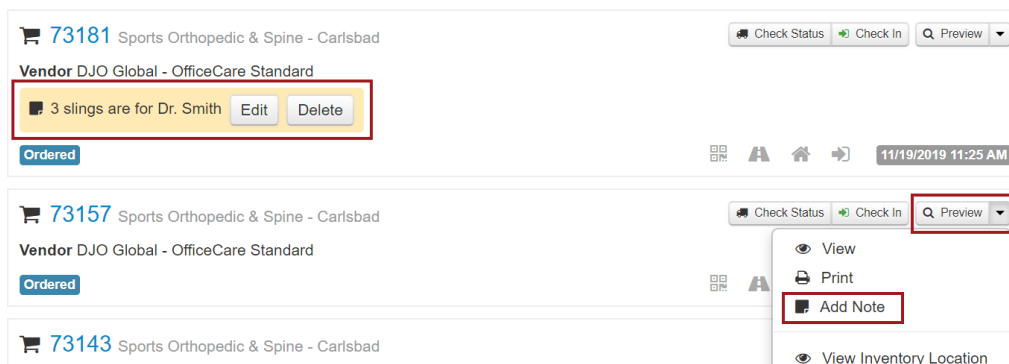

[Business Enhancement] Add Sales Rep Dashboard actions on Accounts page to address Incomplete PAs and Restocks for OfficeCare

[Operational Enhancement] Direct VeriPro users should not see Transaction ID or Card Number text on PA

[Operational Enhancement] Add a new Early Warning notification for Medicaid letting user know the claim might need Authorization

[Operational Enhancement] Update OfficeCare inventory transfer emails so language is clearer

[Operational Enhancement] Remove the 'Pilot' wording from SSO section on login screen

[Operational Enhancement] Update the Provider Usage report to calculate Sum of Revenue column if an Item has a unit of measure conversion factor set

[Operational Enhancement] OfficeCare inventory transfers should search for the OC customer reference number

[Operational Enhancement] Delete inventory locations when deleting an account in backend

[Future Functionality] Allow inventory counts to be tracked

[Future Functionality] Save the previous quantity and outstanding restock quantity when completing a new count so it can be displayed in report

[Future Functionality] Previous quantity and outstanding restock quantity should be added to inventory count report

[Future Functionality] Add additional fields being sent to MIQ from MotionMD

[Bug Fix] Product Activity report is not showing globally set HCPCS

[Bug Fix] MIQ SSO token fields are showing up twice on account edit page

[Bug Fix] User role can be selected outside of the check boxes on user page

[Bug Fix] Notes on the PA Only PDF aren't updating if the user adds/removes notes more than twice

[Bug Fix] Inventory counts 'Item Count' field is not populating

[Bug Fix] Inventory counts 'updated' column is not updating properly

[Bug Fix] Submitted for insurance verification user id is not being populated
