

## MOTIONMD ROLES OVERVIEW

This guide provides an overview of the roles that can be assigned to New Users in MotionMD. Users can only be created or modified by users with the Admin role. To determine the appropriate roles to provide a user, Admins should evaluate which business operations the user needs access to with their job responsibilities.

All roles in MotionMD are based on the following key functions: Claims Management, Inventory Management, and Administration. An overview of the operations a user can perform under those functions is listed below:

**ADMIN:** Account administrator who is responsible for managing users and all aspects of the account. This role is the highest level of visibility and access in the system.

**CLINICAL COORDINATOR:** Recommended for users who oversee the daily management of DME.

**KEY ACCOUNT REP:** Recommended for users with greater responsibility than Clinical Coordinator.

**SALES REP:** Patient claim management with no ability to manage inventory.

**MOTIONMD ROLES OVERVIEW**

**ADD-ON ROLES**

These roles are intended to be utilized in addition to standard roles assigned above to provide additional access to specific features in the platform.

**ANALYTICS:** Administrative role designated for users to have access to the Analytics dashboard.

**INVENTORY ADMIN:** Administrative role designated for users to have access to all inventory management features.

**INVENTORY COUNTS:** Allows users to create and review inventory counts. Does not include permission to apply counts.

**PROTOCOL CREATOR:** Adding this role allows users to access protocol pages to create and manage protocols for providers within the system.

**PSR:** Patient Service Representative responsible for creating PAs and restock orders. Similar responsibilities as the Clinical Specialist role. Adding this role will expand permissions for managing restocks.

**VERIPRO™ COLLECTOR:** Provides visibility to process collections for patient EPR. Adding this role provides users with visibility to the VeriPro™ dashboard in an account enabled with VeriPro™.

**STANDALONE ROLES**

The roles below were designed to be standalone roles. Additional roles assigned to a user with one of these roles will override the permissions.

**BILLING:** A user with this role has access to claims with no inventory permissions.

**CLINICAL SUPPORT TECHNICIAN:** A user with this role has access to only claims and inventory management.

**PA CREATOR:** A role with limited responsibilities. For users who are only creating the Patient Agreement while fitting the patient and need to quickly capture the product and the patient's signature.
